The partial plan of Sector SUPR-24 "Viña Borrego" was definitively approved by agreement of the Town Hall Plenary on December 11, 2003 and was published in the BOP on January 23, 2004. This information is collected in the memory of the adaptation of the PGOU to the LOUA approved by the Plenary of Coín on February 10, 2011 and published the decree on February 22, 2011. The use assigned to each plot is 33.5%, or what is the same 0.335 m<sup>2</sup> of roof / m<sup>2</sup>. The Partial Plan establishes that a Conservation Entity must be constituted for the maintenance of the urbanization. The total number of plots in the Sector with use are 48 units, which have a building area of 10,058.05 m<sup>2</sup>, of this total, 24 plots are for sale and have a use of 5,091.35 m<sup>2</sup>. The City Council will require the updating of the lighting installations, adapting them to the energy efficiency regulations. Full urban report available.
